Representing the Sunshine Coast Youth Soccer Association (SCYSA) on a Competitive Team is a privilege. Players, coaches, managers, and parents are expected to conduct themselves in a respectful and professional manner at all times. Participation in SCYSA's Competitive Pathway depends on a commitment to the standards outlined in this contract.

Please carefully read and check each box to confirm your understanding and agreement.

## **Playing Time Policy**

Coaches guarantee 40% of playing time over the course of the season if the player meets the responsibilities listed below.

Player Commitments
Players will show commitment and accountability to their team by:
☐ Prioritizing attendance at all practices and games
☐ Wearing full SCYSA training kit to every session
□ Notifying coaches/managers in advance if unable to attend
<ul> <li>Arriving at least 15 minutes before training and 45 minutes before matches</li> </ul>
☐ Dressing in full SCYSA uniform for all games
<ul> <li>Bringing both jerseys to every game in case of a color change</li> </ul>
$\square$ Fueling properly before sessions and bringing water/snacks as needed
Players will bring a <b>positive attitude</b> by:
☐ Listening respectfully to coaches, managers, and officials
☐ Asking questions when clarification is needed
☐ Playing any assigned position without complaint and with full effort
☐ Remaining engaged on the sideline and ready to enter the game at any time
$\square$ Supporting teammates both on the field and from the bench
Players will demonstrate <b>good sportsmanship</b> by:
☐ Respecting the decisions of referees
☐ Showing humility in victory and grace in defeat
Shaking hands with opponents and thanking officials after each game
<ul> <li>Avoiding foul or abusive language at all times</li> </ul>
<ul> <li>Avoiding unsportsmanlike behavior (e.g. excessive goal celebrations, chants from the sideline)</li> </ul>

<ul> <li>Use of racist, homophobic, or discriminatory language or behavior</li> <li>Bullying, harassment, or abuse of any kind (in person or online)</li> <li>Disrespect toward parent chaperones or team transport volunteers</li> <li>Disruptive behavior on ferries or in public (e.g. loud conduct, kicking balls, littering)</li> </ul>
